**15** Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ \_\_\_\_\_

Immediately following the December distribution, the reverse share split was performed on 12/13/13. The Fund's share price was raised to the same level as before the distribution, while the share balance of each account in the Fund was reduced proportionately. To accomplish this, the reverse share split factor was calculated as follows: share price after the reverse share split divided by the share price before the reverse share split. For Class BTFTX, this would be \$107.57 divided by \$114.23, or a reverse share split factor of 0.9417. For Class ACTTX, this would be \$103.85 divided by \$110.23, or a reverse share split factor of 0.9421.
