As a result of the reorganization, the shareholders of all classes of NT Mid Cap Value Fund exchanged their shares for shares in the same respective class of Mid Cap Value Fund equal in value to the aggregate net asset value of the shares surrendered. However, the cost basis per share of NT Mid Cap Value Fund shareholders have changed basis upon the number of shares received from Mid Cap Value Fund.
