**14** Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ► On April 22, 2022, the American Century World Mutual Funds, Inc. - International Growth Fund (EIN: 43-1567889) acquired all of the assets and assumed all of the liabilities of American Century World Mutual Funds, Inc. - NT International Growth Fund (EIN: 20-4432377) in a tax-free reorganization. As a result of the reorganization, the shareholders of all classes of NT International Growth Fund exchanged their shares for shares in the same respective class of International Growth Fund equal in value to the aggregate net asset value of the shares surrendered. See attached schedule for details of the exchange.

**15** Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ► After the reorganization, the shareholders of NT International Growth Fund received shares of International Growth Fund. The shareholders' aggregate tax basis of the shares received from International Growth Fund are the same as the shareholders' aggregate tax basis surrendered by NT International Growth Fund. However, the cost basis per share of NT International Growth Fund shareholders have changed basis upon the number of shares received from International Growth Fund.
