14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ► American Century World Mutual Funds, Inc. - NT International Growth Fund paid a taxable distribution to its shareholders of record on April 18, 2022. American Century World Mutual Funds, Inc. - NT International Growth Fund has determined that a portion of the distribution is return of capital, as the fund did not have enough current or accumulated earnings and profits to support a taxable distribution. See the attached statement for details.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ► American Century World Mutual Funds, Inc. - NT International Growth Fund paid a taxable distribution to its shareholders of record on April 18, 2022. For this distribution, 15.83% represents a non-taxable return of capital to the extent of a U.S. shareholder's tax basis in each of its American Century World Mutual Funds, Inc. - NT International Growth Fund shares, with any remaining amount being taxed as capital gain to a U.S. shareholder.

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ► American Century World Mutual Funds, Inc. - NT International Growth Fund has determined that a portion of the April 2022 taxable distribution is a return of capital as the fund did not have enough current or accumulated earnings and profits as of the fiscal year ending April 22, 2022. Of the distribution amount that American Century World Mutual Funds, Inc. - NT International Growth Fund distributed in April 2022, 15.83% has been determined to be a return of capital.
