14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ► American Century Asset Allocation Portfolios, Inc. - One Choice Blend+ 2015 Portfolio paid a taxable distribution to its shareholders of record on April 7, 2025. American Century Asset Allocation Portfolios, Inc. - One Choice Blend+ 2015 Portfolio has determined that a portion of the distribution is return of capital, as the fund did not have enough current or accumulated earnings and profits to support a taxable distribution. 15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ► American Century Asset Allocation Portfolios, Inc. - One Choice Blend+ 2015 Portfolio paid a taxable distribution to its shareholders of record on April 7, 2025. For this distribution, 44.12% represents a non-taxable return of capital to the extent of a U.S. shareholder's tax basis in each of its American Century Asset Allocation Portfolios, Inc. - One Choice Blend+ 2015 Portfolio shares, with any remaining amount being taxed as capital gain to a U.S. shareholder.

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ► American Century Asset Allocation Portfolios, Inc. - One Choice Blend+ 2015 Portfolio has determined that a portion of the April 2025 taxable distribution is a return of capital as the fund did not have enough current or accumulated earnings and profits as of the fiscal year ending April 11, 2025. Of the distribution amount that American Century Asset Allocation Portfolios, Inc. - One Choice Blend+ 2015 Portfolio distributed in April 2025, 44.12% has been determined to be a return of capital.
