- 14** Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ► On June 13, 2025, the American Century Asset Allocation Portfolios, Inc. - One Choice In Retirement Portfolio (EIN: 20-1257443) acquired all of the assets and assumed all of the liabilities of American Century Asset Allocation Portfolios, Inc. - One Choice 2025 Portfolio (EIN: 20-1256021) in a tax-free reorganization. As a result of the reorganization, the shareholders of all classes of One Choice 2025 Portfolio exchanged their shares for shares in the same respective class of One Choice In Retirement Portfolio equal in value to the aggregate net asset value of the shares surrendered. See attached schedule for details of the exchange.
- 15** Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ► After the reorganization, the shareholders of One Choice 2025 Portfolio received shares of One Choice In Retirement Portfolio. The shareholders' aggregate tax basis of the shares received from One Choice In Retirement Portfolio are the same as the shareholders' aggregate tax basis surrendered by One Choice 2025 Portfolio. However, the cost basis per share of One Choice 2025 Portfolio shareholders have changed basis upon the number of shares received from One Choice In Retirement Portfolio. See attached schedule for exchange ratios.
- 16** Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ► The tax basis of the shares of One Choice In Retirement Portfolio received in the reorganization was determined by dividing the aggregate tax basis of the shares surrendered by One Choice 2025 Portfolio by the total number of shares of One Choice In Retirement Portfolio received in the reorganization.
