14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ► American Century Capital Portfolios, Inc. - Real Estate Fund paid quarterly income distributions to its shareholders of record from March 2025 to September 2025. American Century Capital Portfolios, Inc. - Real Estate Fund has determined that a portion of each distribution is return of capital, as the fund did not have enough current or accumulated earnings and profits to support an ordinary income distribution. See the attached statement for details.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ► American Century Capital Portfolios, Inc. - Real Estate Fund paid quarterly income distributions to its shareholders of record from March 2025 to September 2025. For each of these distributions, 12.44% represents a non-taxable return of capital to the extent of a U.S. shareholder's tax basis in each of its American Century Capital Portfolios, Inc. - Real Estate Fund shares, with any remaining amount being taxed as capital gain to a U.S. shareholder.

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ► American Century Capital Portfolios, Inc. - Real Estate Fund has determined that a portion of each quarterly distribution is a return of capital as the fund did not have enough current or accumulated earning and profits as of the fiscal year ending October 31, 2025. Of each of the distribution amounts that American Century Capital Portfolios, Inc. - Real Estate Fund distributed from March 2025 to September 2025, 12.44% has been determined to be a return of capital.
