Distinguishing Characteristics

One Choice Blend+ Portfolios are actively managed asset allocation funds that are designed to be a comprehensive investment solution. These funds automatically adjust their asset mix over time and reach their most conservative allocation approximately five years after the target date. The portfolios generally become more conservative by decreasing the allocation to stocks and increasing the allocation to bonds and short-term investments.

The One Choice Blend+ Portfolio's target date is the approximate year when investors plan to retire or start withdrawing their money. The principal value of the fund is not guaranteed at any time, including at the target date.

As of that date, all references to One Choice Blend+ 2020 Portfolio will be replaced with One Choice Blend+ In Retirement Portfolio.
