## Investment Objective

Seeks long-term capital appreciation through investment in an actively managed portfolio of equity and equity-related securities issued by small capitalisation companies in developed countries.

## Investment Approach

- The Fund invests in a broad set of small-cap developed market equity and equity-related securities across all market capitalisations and is designed to increase expected returns by overweighting securities we believe to be trading at lower valuations and with higher profitability ratios.
- The Investment Manager pursues the benefits associated with indexing (diversification, low turnover, transparency of exposures), but with the ability to add value by making investment decisions using information in current prices.
- The Fund's efficient portfolio management and trading process are designed to enhance returns while seeking to reduce unnecessary risks and costs for investors.
